D10 Council Candidates Kathy Stewart And Brian Hasenbaum Respond to Questions Asked By Neighbors

Ouestions were submitted to all 4 candidates.

Kathy Stewart

LH PID to Include Walnut and Audelia:

I am a big advocate for public improvement districts (PIDs). I helped create the North Lake Highlands PID. As the D10 Councilmember, I would support expanding the boundaries of the North LHPID to include the commercial and apartment Walnut properties at Audelia.

On Working with Apartment Owners on Reducing **Crime:**

completely support the monthly meetings that the DPD Northeast Division hosts for the property managers in the North Lake Highlands area. As the former Executive Director of the Lake Highlands PID and the North Lake Highlands PID, I attended these meetings. As the D10 Councilmember, I will meet with the North Lake Highlands property managers individually and encourage them to participate. I commit to attending the meetings as well.

On Distributing City and **Financial Resources in D10**

I have advocated for City resources for North Lake Highlands since 2015. I advocated for the improvements to LBJ East because it brought continuous frontage roads and the tied arch bridge to the area. During the design phase, I made sure that green space was set aside for gateway signage on both the north and south sides of the bridge.

On Expanding the North I supported Deputy Chief Andy Accord in his efforts to get the boxing gym put in on the northwest corner of Forest and Audelia.

> I kept reminding our leadership that there are very few city services north of LBJ. I was thrilled to hear the City purchased one of the worst shopping centers in the area (northwest corner of Forest/ Audelia) - and will soon replace it with a City park and other City resources.

On Zoning to Ban Short Term Rentals (STRs) from **Residential Neighborhoods**

I support a ban on short-term rentals in neighborhoods that are zoned single family residential. Most single-family homeowners do not want short-term rentals in their traditionally residential neighborhoods, and I agree. We have experienced the "party house" too many weekends with overcrowding, overconsumption of alcohol, and noise.

On Implementing Changes at Friendship Park

I don't have enough information on the ranking of improvements to address this question. Some of the improvements are complete but I noticed that the basketball court is still there. I recall from the community meetings, that the neighborhood wanted the court removed. I would advocate for its removal.

Brian Hasenbauer

On Expanding North Lake Highlands PID to **Include Walnut and** Audelia:

I support the work of the PID and would be receptive to expanding their work if the benefits are clearly outlined to the neighborhoods impacted. would like to hear more from businesses and homeowners in the area mentioned for additional feedback.

On Working with Apartment Owners on Reducing homelessness. **Crime:**

I would continue to have regular feedback meetings with DPD, Code, Community Prosecutors, the PID, etc., to hear concerns and work together to hear the concerns of the apartment managers on how we can help them provide a safe living environment for their residents. For negligent or irresponsible property owners, we need to use all available tools (additional police presence, neighborhood

patrols, code, community prosecution, etc.) to reduce criminal activity in the apartments responsible for the crime.

On Distributing City and **Financial Resources in D10:**

There are numerous priorities I District have for 1. Bask to basics. Safer, cleaner neighborhoods and streets. This includes hiring more police officers and increasing focus on road repair and infrastructure.

- 2. Reduce panhandling and
- 3. Lowering taxes and ensuring more timely responses to 311 complaints, and making government work for you.

On Zoning to Ban Short Term Rentals (STRs) from **Residential Neighborhoods:**

Based on where we are in the discussion, I would like to see STRs banned from residential neighborhoods and limited to areas already zoned for hotels and lodging. We need to keep our neighborhoods safe.

Chris Carter and Sirrano Keith Baldeo did not respond to the questions submitted.

Notes from the April 11th Candidate Forum on the Four Candidates Vying for the D10 Council Seat

Mike Gorman attended the Candidate Forum and took notes on comments made by the candidates, some of which are listed below. Whoever gets elected, our neighborhood needs to make sure the person is aware that we are here and what our needs are. The tendency has been for emphasis to be on the Lake Highlands neighborhood since that is where most of the D10 Council reps reside. Our neighborhood is in the area north of 635 called North Lake Highlands.

Kathy Stewart

Extensive background experiences with the city as director of both the Lake Highland and the Uptown PIDS. Was also on the Arts and Culture Commission.

Backed by DPD and Fire Department Association.

Her focus is will be on citizens of D10.

Will be available and answer questions from constituents.

Is positive on Adam McGough's performance. Says without him there would be no improvements to LBJ and Hamilton Park.

Feels laws should be enforced with compassion, using case workers effectively.

D10 has more affordable housing than any other district.

Will work to increase DPD staff and focus on apartment crime.

Has been advocating for D10 since 2004. Wants more identity for Lake Highlands.

Pushed for free service roads along LBJ

Sirrano Keith-Baldeo

Used quotations from the Bible.

Said he will expose City Hall corruption in the paper he publishes.

Will be a dog that bites.

Plans to keep pressing to enforce laws.

Worked to clean up Forest and 75.

Strongly dislikes the park idea at Forest and Audelia.

Feels money is wasted on wrong programs.

Brian Hasenbauer

Worked on commissions for Adam McGough and remains positive on his performance.

Feels there should be more housing for homeless that are looking for help.

Supports building drug and mental health facilities and increasing shelter space.

Says more affordable housing needed.

Need DPD to have nice community amenities.

Approves of Chief Garcia's datadriven approach.

Feels his focus should be on both City and D10, working with other districts to increase green space and keeping parks clean.

Chris Carter

Is a fiscal conservative predicting financial collapse for Dallas.

Is negative on Adam McGough's performance. Feels he's never available and is in developers' pockets.

Doesn't like social programs. Wants the federal government to handle them

Wants to pay police more. Feels city manager and staff make too much.

Made frequent comments about City council being too leftist.

Will focus his work on D10.

Says pension fund program for city will halt everything.

All of these candidates have indicated they support the KISS proposal, or are for zoning of residential areas only.

Let's Make Sure the City Knows What We Need Done to Make Our Streets Safe

Requests for street, curb, and gutter repairs should be submitted through 311. The request should include block numbers and between which streets.

The reason for calling 311 is that there is a record of the request and a person with the required department must reply to you by email or call by a certain time. Always ask for an email from whoever replies to you so that you have a record that you can save.

Code Regulations Often Violated

OVERSIZED VEHICLES

(Sec. 28-81) No person may park a truck-tractor, road tractor, semi-trailer, bus, trailer or truck over one and one-half tons upon property or any public right-of-way abutting a Residential Area. \$20 Civil Penalty

24-HOUR PARKING

(Sec28-84) No person may park an unattended vehicle in a public street, alley or other public place continuously for longer than 24 hours. \$15 Civil Penalty

FENCE

(Sec 27-11(b)(10) An owner shall (A) maintain any fence on their property so it is not out of alignment more than 12" for a fence over 4feet; 6"for a fence 4 feet or less. (B) repair or replace rotted, fire damaged, or broken wooden slats and support rods. The fine: \$200-\$2000

SIGNS

(Sec 7A-16) No person shall post any notices to any lamppost, pole, or tree located on a public right-of-way, structure or building.

Update on Short Term Rentals

Currently, the majority of the Dallas City Council voted to send the KISS (Keep It Simple Solution) recommendation regarding residential zoning back to a task force for another presentation of information. There will be no vote before the May 6th election Reports of problem properties usually rise as summer approaches.

STR Facts:

The US Supreme Court Approved City's Rights to Zoning in the Euclid, Ohio case in 1927.

The City of Dallas confirmed it's right to zoning in 1934 case Lombardo vs City of Dallas

All property owners that started a commercial operation of renting out residential units for less than 30 days have been breaking the law.

They broke the law by not confirming current zoning that was in place and did not ask for an exemption.

The majority of STR owners do not voluntarily notify the City of Dallas about their properties and their intended operation. Nor do they voluntarily pay the City the Hotel Occupancy Tax of 9% for each stay.

The majority of Short-Term rental owners, On-Line Travel Agencies (OTA) like Airbnb, VRBO, etc. will not voluntarily share the property addresses of hosts with the City.

Basics

- Permit from City is required
- There is a limit of two (2) garage sales at a premise during any twelve (12) month period (**NOT** by calendar year) and each sale may not exceed more than three (3) consecutive calendar days in length.
- Signs must be placed on private property; Signs placed on medians, public property or utility poles are illegal
- Signs must be removed within 24 hours of sale.
- 1st Garage Sale -No Fee
- 2nd Garage Sale -\$25.00 (No Cash)

<u>Metals</u>--steel, tin and aluminum **NO** foil or foil conainers used for baking; no electronics or toys

<u>Paper Products and Cardboard</u>--newspapers, books (both paper and hardback) magazines, catalogs, envelopes, food and detergent boxes, paper egg cartons, 1-pack drink cartons, cereal boxes, folded corrugated and cardboard boxes; **NO** food contaminated boxes or plastic or foil-lined boxes or shredded paper
